3. The owner of the Subject of the Procedure is Morska Stocznia Remontowa "Gryfia" S.A.

The opening of the tenders takes place on **19.06.2023 at 12:00** at the shipyard's registered office.

4. It is permissible to send the Tender via mail or courier companies and the submission date of the Tender is the day and time of its receipt at Morska Stocznia Remontowa "Gryfia" S.A.

5. One tenderer may submit only one Tender at the time of submission of tenders.

6. If several tenderers submit tenders with the same highest price, the tender, at the discretion of MSR S.A., may be continued in the form of an auction between the tenderers. The tenderers who have submitted equivalent tenders will be notified in writing on the date and place of the auction. In such a case, the bid deposit is returned after the auction has been settled.
