In response to needs of the environment, MSR "GRYFIA" S.A. is determined to constantly improve quality of rendered repair services and conducted production activity by means of efficient and effective management, bearing in mind issues such as: observance of provisions of law in force, Health and Safety at work regulations in force, commitment to prevent occupational injuries and diseases, to constantly improve level of safety, to protect the environment, to stick to regulations of classification institutions, and in particular to meet requirements of customers.
